### In Process/Continuing/Upcoming Activities

- Lunch scheduled with Carmen Jackinsky (2024 Contributor of the Year) on 11/21 to present her award.
- Identify approach for increasing Youth participation in Race Walking. Will be talking with other Race Walk chairs at the 2024 USATF Annual Meeting to learn about other associations are using. There's also a video that is being developed by Ian Whatley on How to Coach Youth Race Walking. Ian is a longtime friend (and has given me some coaching in my competitive race walking days) so will talk with him about availability and logistics. I've heard from coaches that the first challenge to address is that coaches don't know much about/how to coach racewalking so we need to develop a roadmap to teach coaches how to coach race walking.
- Continue to provide updated event information (results, event times, etc.) to Phil Sutton for addition to the Race Walk Page on the USATF Oregon website.
- Identify dates for monthly one-hour Race Walk Judging/Officiating reviews via Zoom we'll start these again in January. Clinic was designed as a basic overview and review and Q&A session.
- Working with Scott Phoenix to identify dates for Race Walk Judge/Official recertification activities for 2025 – 2028 Olympiad.


